### Kuala Lumpur – Kiara East / 6Kapas / Bandar Ligamas

- First phase of Kiara East, DEX Suites commercial spaces is almost fully tenanted, thus realising SBC's place making efforts to activate the community amenities.
- The second phase of Kiara East is pending planning approval and target to launch will be very much supported by the re-establishment of normal residential purchasing behaviours and the availability of end-financing in the market.
- 6Kapas, the location that gives its residents the panoramic view of the KL skyline , is completed in Q2 2022. Tower B is almost fully sold, and Tower A is now open for sales.
- Ligamas Residences' sales achievement came within expectations, and the Group anticipates the sales of the remaining phase will come through.
